I (We) understand and agree that the mare(s) shall be in healthy and sound breeding condition and that a veterinarian's certificate (culture) shall accompany each mare. Failure to furnish this will automatically authorize the Stallion Owner to have the mare examined at the expense of the mare(s) owner. A copy of the registration papers front & back are to be furnished. A **negative coggins** is required at time of mare arrival at Single B Farm. Mares that are not halter broken or hard to handle will not be accepted. The rear shoes must be removed.

Stallion owner has the right to decline to breed to any mare. If mare is declined, breeding fee will be returned to mare owner.

It is further agreed that should the above named Stallion die, or become unfit to service, or if the mare dies, or becomes unfit to breed, then this contract shall become null and void. No mare substitution will be accepted without prior approval from stallion owner and all documentation for said mare received.

I (we) do agree to pay \$ **800.00** Breeding Fee and a \$ **200.00** booking fee is due at time of signing contract. (booking fee will be subtracted from breeding fee total). The booking fee is non refundable. Mare care : \$ **18.00** per day mare care (wet), \$ **15.00** per day mare care (dry). Stallion breeding fee is due prior to mare being delivered. All fees and expenses are to be paid in full prior to mare being picked up. If the afore mentioned fees and expenses are not paid, The Stallion Owner reserves the right to assert a breeder's lien. All cost incurred collecting delinquent charges shall be the responsibility of the Mare Owner. These costs include but are not limited to the following: Court Cost, Attorney Fees, and Skip Tracing. Mare owner may not remove mare from breeders' possession until all expenses are paid in full. Deposits are non-refundable

The Stallion Owner will guarantee  Live Foal for all non Thoroughbred mares.

Live Foal Guarantee is defined as a new born foal, which stands and nurses without assistance. If the foal is born dead, or if the mare does not otherwise carry to term, there shall be a return privilege for the following breeding season only if stallion owner is properly notified. Stallion owner must be notified by written statement from a licensed veterinarian within one week from the date of death.

The Stallion Owner/Agent agrees to sign all papers/forms necessary to register the foal

This contract is non-transferable. Both parties agree that the breeder or any person associated with the procedure is not liable for death, sickness and/or accident caused to the mare and/or foal; and the mare owner is not liable for death, sickness and/or accident caused to the Stallion. This contract will be interpreted and enforced under the laws of the state of North Carolina.

**Under North Carolina law, an equine activity sponsor or equine professional is not liable for an injury or to the death of a participant in equine activities resulting exclusively from the inherent risks of equine activities, Chapter 99E of the North Carolina General Statutes.**
